

By registering, participants accept the competition rules and the legal and procedural rules as binding. These rules serve to ensure uniform and equal opportunities for the sport and cannot be contested in court. Compliance with and acceptance of them is a basic requirement for participation in the event. Each participant is responsible for the technical safety of their own equipment and must ensure that it complies with the rules. The organizer accepts no liability for accidents, personal injury or property damage, theft or other damage!

## Declaration

1. I declare that I am familiar with the competition regulations and organizational guidelines according to the official announcement in the latest version and that I agree with them.
2. I confirm that there are no medical objections to my participation and that my training and health status meets the requirements of the competition.
3. I am informed of the health and other risks and circumstances associated with the competition and expressly confirm that I am participating in the event at my own responsibility and risk.
4. At the same time, I assure that I and my legal successors will not make any legal claims or demands against the organizer, its employees or commissioned companies or persons, clubs and all affected communities and other persons and entities.
5. I agree to any medical treatment at my own expense if this should be advisable in the event of injuries occurring in the event of an accident and/or illness during the course of the competition.
6. No claims for recourse or refund of registration fees are possible in the event of force majeure, postponement or cancellation of the event.
7. I agree that the photos, film recordings and other audio or video recordings made in connection with the event and depicting me as well as my name may be used free of charge and without restriction by all types of media (e.g. in the context of television broadcasts, Internet presentations, etc.). Likewise, my image and my name may be used free of charge and without restriction for all types of printed matter, even if they are used for advertising purposes for this or another similar event (e.g. brochures, posters, etc.).
8. I hereby release the organizer, the organizers, employees and helpers of the Trumer Triathlon from all liability claims, provided that these are not due to gross negligence or intent and are not covered by statutory liability. This includes all direct damages, as well as all claims that I or my legal successors or other authorized third parties can assert due to injuries sustained or in the event of death.
9. I agree that my data may be stored electronically and made available to partner companies.
10. The entry fee cannot be refunded, except if the registration is not accepted. The starting place cannot be transferred to the next event year or to another person or event.
11. I will attend the competition briefing and follow the rules of conduct given there.
12. I will follow the instructions of the officials and other competition staff.

## Doping

By participating, the athlete undertakes to comply with the anti-doping regulations of the Federal Anti-Doping Act 2021 and the relevant regulations of the responsible national and international sports association (in particular statutes, sports regulations, competition regulations). Athletes are persons who are members or licensees (annual or daily license) of a sports organization or an organization affiliated with it, or who were at the time of a potential violation of anti-doping regulations, or who participate in competitions organized by a sports organization or an organization affiliated with it or funded by federal sports funding. The organizer and the host strictly reject doping. As a participant, you confirm that you have not taken or used any prohibited substances or methods for doping purposes, or that you will not take or use any prohibited substances or methods for doping purposes. If the participating athlete is required to take prohibited substances or use prohibited methods according to a medical or dental diagnosis, athletes in the test pool must apply for a medical exemption in advance. All other athletes are also strongly advised to keep all medical certificates and findings for a possible retroactive medical exemption. ## Anti-Doping Kodex

The performance of competitive performance without the use of illegal means and measures is a basic requirement for the event. For this reason, the STAR RIBBON campaign ([www.starribbon.com](http://www.starribbon.com) - Anti Doping Awareness) of the Austrian Sport Union is supported and, in cooperation with other triathlon events in Salzburg and Austria, the following anti-doping code is included in the conditions of participation:

1. I reject the faking and fraudulent attainment of measured performances through doping, drug abuse, manipulation or other reckless and fraudulent behavior.
2. I undertake not to take any prohibited substances to increase physical performance in order to perform athletically.
3. I also guarantee that I will only take medication if there is a medical indication and that, for my own protection, the medication prescribed to me does not contain any substances that are on the international doping list.
4. If I am convicted under anti-doping regulations, I undertake to repay all grants, prize money and sponsorship money that I have received in the previous three years to the donors.
5. By participating, I agree to doping tests and I accept the ÖTRV guidelines and competition conditions.

By registering or registering online, I accept the applicable ÖTRV regulations, the facts described in the announcement and the regulations, the conditions of participation mentioned above and thereby declare my consent. When registering minors, the consent of the parents or legal guardian is required.
